## Mini eUpdate from Northants CALC

It's a **Thursday** mini *eUpdate* this week due to the long weekend coming up.

## **Procurement Changes**

As mentioned in previous *eUpdates*, open invitations for local authority contracts estimated to be over £30,000 including VAT must be published on Find a Tender (<a href="https://www.find-tender.service.gov.uk">https://www.find-tender.service.gov.uk</a>) rather than on Contracts Finder, which is now defunct. This is one of the changes brought about by the **Procurement Act 2023**, which came into force on 24 February 2025. The National Association of Local Councils (NALC) has produced new Model Financial Regulations and new Model Standing Orders to reflect the requirements of the Procurement Act and, as promised, Northants CALC has produced a paper that member councils can take to a council meeting just to approve the minor things that have changed. Therefore, councils in Northamptonshire have the option of **either** adopting the new templates whole (customisation to each council's circumstances is required) **or** approving the minor wording adjustments and simply updating their existingFinancial Regulations and Standing Orders. ## **Marking VE and VJ Day**

In March, the government announced a series of celebrations and events to mark the 80th anniversaries of Victory in Europe (VE) and Victory over Japan (VJ) Days that will share stories of the Second World War generation. Commemorations will begin on the early spring Bank Holiday, 5 May 2025, with the Cenotaph dressed in Union flags, a Military procession, and a flypast in London. Street parties will also be held across the country and a ceremony on HMS Belfast will start community celebrations. The 8 May 2025 will see a service of remembrance and thanksgiving at Westminster Abbey followed by a concert. The 80th anniversary of the end of the war in the Far East will be marked with a service on 15 August 2025. **Councils are encouraged to promote street parties and community get-togethers on Monday 5 May 2025**. The National Lottery Community Fund is making their 'Awards for All' programme available to organisations to bid for grants to support communities coming together for these commemorative events. Health and Safety Executive's Working Minds campaign (<a href="https://workright.campaign.gov.uk/campaigns/working-minds/">https://workright.campaign.gov.uk/campaigns/working-minds/</a>) identifies five simple steps to help to prevent stress and support good mental health:

- Reach out and have conversations
- **Recognise** the signs and causes of stress
- **Respond** to any risks identified by agreeing action points
- **Reflect** on the actions taken have things improved?
- Make it routine to check back in on how things are going
